RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF SARASOTA COUNTY, FLORIDA

RESOLUTION NO. 2016-____

RE: DESIGNATING DOG-FRIENDLY AREAS IN SPECIFIED SARASOTA COUNTY PARKS, PRESERVES AND TRAILS.

WHEREAS, Section 90-33 of the Sarasota County Code prohibits dogs, cats and other pets in County-owned parks but allows for areas to be specifically designated for activities involving animals such as dogs; and

WHEREAS, Section 14-48 of the Sarasota County Code prohibits animals in certain public areas including parks, it indicates that the Board may designate specific sites by resolution; and

WHEREAS, Section 14-48 of the Code also requires dog owners to immediately pick up after their pets and dispose of their droppings in a lawful manner; and

WHEREAS, Section 14-41 of the Sarasota County Code requires that dogs shall not be permitted to run at large and shall be leashed; and

WHEREAS, Sarasota County recognizes that citizens and visitors wish to enjoy public outdoor recreational spaces with their dogs; and

WHEREAS, Dog parks (also known as paw parks) serve as places where dogs can safely be offleash in a fenced area specifically designed for such use and Dog-friendly parks, preserves and trails are places where pets are welcome, but must be leashed at all times within the areas designated as such; and

WHEREAS, designating dog-friendly areas in parks, preserves and trails will contribute to the health and well being of dogs and their owners; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS:

- 1. That the above recitals are true and correct and by this reference are incorporated herein.
- 2. That the Board hereby approves the designation of dog-friendly areas in the County-owned sites listed in Exhibit A.
- 3. That appropriate signage, guidelines and other information will be posted to identify these sites and the designated areas therein.
 - 4. That the Effective Date of this Resolution shall be January 1, 2017.
 - 5. This Resolution shall supersede and replace Resolution No. 2012-048.
